MEMORANDUM OF UNDERSTANDING

AND

Rajamangala University of Technology Thanyaburi based at Rangsit-Nakhon Nayok, Pathum Thani, 12110, Thailand (hereinafter referred to as RMUTT)

This MOU is made today on Monday of July 28, 2010 by **UIB** and **RMUTT** (hereinafter referred to as **Parties**) wish to record our mutual understanding as follows:

- The **Parties** are desirous of integrating their respective skills, strengths and resources with the aim to synergize and work closely with each other for a mutual benefit in the education and research fields.
- The education collaboration between both **Parties** may cover but not limited to student exchange, credit transfer, and/or joint program.
- The education collaboration shall promote international intellectual development of both **Parties** through faculty members and administrators exchange.
- As an effort to internationalize the long life learning process, both **Parties** shall prepare to establish research collaborations.
- Both **Parties** agree for the duration of this MOU, to cooperate and collaborate in good faith to execute all acts and things and render all assistance to each other.
- The **Parties** hereto have also agreed that this MOU shall be effective on the day of signing hereof and the implementation of such programs shall be based on separate contractual arrangements respectively. None of the **Parties** hereto shall have any authority to bind the other in any way with this MOU.
- The operation of this MOU works on the premise that there shall be transfer of technology and information between the **Parties** involved in the spirit of mutual cooperation.
- No provision of this Memorandum of Understanding shall be waived, altered or amended except in writing signed by the party against whom such waiver, alteration or amendments is asserted. Any such waiver shall be limited to the particular instance and the particular time when and for which it is given.

- This MOU shall be evaluated and updated on a periodic basis.
- This MOU shall be followed up by a Memorandum of Agreement which specifies the details of collaboration within six months after the signatory of this MOU.
