GENERAL AGREEMENT FOR ACADEMIC EXCHANGE BETWEEN

RAJAMANGALA UNIVERSITY OF TECHNOLOGY THANYABURI AND

KYOTO INSTITUTE OF TECHNOLOGY

Rajamangala University of Technology Thanyaburi and Kyoto Institute of Technology agree to facilitate academic exchange between our institutions to promote academic studies in scientific fields, as below:

- 1. Rajamangala University of Technology Thanyaburi and Kyoto Institute of Technology will facilitate the following activities regarding academic exchange:
 - (a) Exchange of faculty members and research scholars;
 - (b) Joint research activities;
 - (c) Exchange of students;
 - (d) Exchange of research materials, academic publications, and other information;
 - (e) Other academic exchanges to which both parties agree
- The details of this agreement will be separately negotiated and agreed upon in writing by both institutions. It is understood that neither party has any financial obligation to the other party under this agreement.
- This agreement becomes effective on April 1st, 2012 regardless of the date on which it is signed, and is valid for a period of five years from that date.
- 4. Extension or amendment of this agreement, or termination prior to the end of the five-year period, is to be effected after mutual consultation by the institutions.
- This agreement is based on reciprocity. The benefits for, and liabilities of this exchange program will be kept as balanced as possible for each institution.

MEMORANDUM ON STUDENT EXCHANGE BETWEEN

RAJAMANGALA UNIVERSITY OF TECHNOLOGY THANYABURI

AND

KYOTO INSTITUTE OF TECHNOLOGY

Based on the Agreement between Rajamangala University of Technology Thanyaburi and Kyoto Institute of Technology, our institutions have further agreed to this Memorandum regarding an exchange program for undergraduate and graduate students.

This Memorandum is effective for a period of five years beginning on April 1st, 2012. In the last year of the five-year period, both institutions will determine whether it is to be extended.

- 1. Rajamangala University of Technology Thanyaburi can send no more than two degree students per academic year to be admitted to Kyoto Institute of Technology according to the following conditions:
 - (1) Rajamangala University of Technology Thanyaburi will submit applications for students with appropriate endorsement to Kyoto Institute of Technology. Prior to the application, the coordinator of Rajamangala University of Technology Thanyaburi will contact his or her counterpart at Kyoto Institute of Technology to determine appropriate subjects, the granting/transfer of credits, term of enrollment and the advising (or supervising) faculty for the applicant. This information must be included in the application form. Final selection and approval will be made by Kyoto Institute of Technology based on the prescribed admission processes.
 - (2) Exchange students must have the sufficient language ability to be able to follow the course of study.
 - (3) The status of exchange students will be that of "International Exchange Student" (non-degree student). These students may enroll from the first day of any month for not less than one month or more than one year. Students registering for classes, however, must enroll at the beginning of a semester (April 1 or October 1) for a minimum period of one semester and a maximum of one year.
- 2. Kyoto Institute of Technology can send no more than two degree students per academic year to be admitted to Rajamangala University of Technology Thanyaburi, according to the following conditions:
 - (1) Kyoto Institute of Technology will submit applications for students with appropriate endorsement to Rajamangala University of Technology Thanyaburi.

Prior to the application, the coordinator of Kyoto Institute of Technology will contact his or her counterpart at Rajamangala University of Technology Thanyaburi to determine appropriate subjects, the granting/transfer of credits, term of enrollment and the advising (or supervising) faculty for the applicant. This information must be included in the application form. Final selection and approval will be made by Rajamangala University of Technology Thanyaburi based on the prescribed admission processes.

- (2) Exchange students must have the sufficient language ability to be able to follow the course of study.
- (3) The status of exchange students will be that of Visiting Overseas Student (non-degree student) or Visiting Overseas Research Student. The term of enrollment for Visiting Overseas Students shall commence at the beginning of a semester and shall not be more than one year or less than one semester. The term of enrollment for Visiting Overseas Research Students shall commence on the 1st of the month and continue on a monthly basis, for not more than one year.
- 3. The following conditions are applicable to exchange students of both Rajamangala University of Technology Thanyaburi and Kyoto Institute of Technology:
 - (1) Each institution will fully honor the credits and grades awarded by the other, and those credits and grades will count toward graduation at the home institution according to its system.
 - (2) Each exchange student will directly pay regular tuition fees to his or her own institution during the period of exchange. The host institution will charge no additional tuition, entrance or examination fees. However, costs of medical insurance are to be borne by the exchange student.
 - (3) The host institution will accept no financial responsibility for exchange student round-trip travel expenses, room and board, books, transportation or other incidentals.
 - (4) Rajamangala University of Technology Thanyaburi and Kyoto Institute of Technology will advise exchange students with respect to local arrangements, such as lodging, board and transportation.
- 4. It is intended that the number of exchange students participating from Rajamangala University of Technology Thanyaburi and from Kyoto Institute of Technology will be approximately the same.
- 5. Any difficulties or problems that arise in administering this Memorandum will be settled by the Presidents, the Deans and/or the Coordinators of the respective

institutions in mutual consultation.
