


AGREEMENT OF ACADEMIC AND EDUCATIONAL COLLABORATION BETWEEN THE COLLEGE OF EDUCATION, DE LA SALLE

The College of Education of De La Salle University-Dasmariñas and the Demonstration Innovation School under the Faculty of Technical Education of Rajamangala University of Technology Thanyaburi hereby agree to promote academic and educational collaboration between the two entities (hereinafter referred to as 'The College of Education of De La Salle University-Dasmariñas and the Demonstration Innovation School under the Faculty of Technical Education of Rajamangala University of Technology Thanyaburi') with the joint purposes of improving mutual understanding between the College of Education of De La Salle University-Dasmariñas and the Demonstration Innovation School under the supervision of the Faculty of Technical Education of Rajamangala University of Technology Thanyaburi; and of contributing to the advancement of academic and educational activities in areas of mutual interest.

Contents of the Collaboration Program

- 1. The two entities agree specifically to promote:
 - (1) the exchange of academic and administrative staffs;
 - (2) practice teaching of student-teachers under the practicum program
 - (3) the exchange of academic findings, publications, and other academic and educational information as appropriate; and
 - (4) other academic and educational collaboration and exchange approved as appropriated by the two <u>entities</u>.

Implementation of the Collaboration Program

2. Specific activities in line with the general areas of collaboration as listed above are to be carried out after mutual consultation and agreement between the two entities.

Terms of the Agreement

3. This agreement shall become effective when the representatives of the two <u>entities</u> sign below, and shall remain effective for a period of 5 years. This agreement may be renewed for a further period of 5 years by mutual agreement. This agreement is only binding for two entities and cannot represent the two universities in anyway.

Revision of the Agreement

4. The two entities must confer with each other (through the International Strategy Division on behalf of RMUTT and through the International Linkages on behalf of DLSU-D), should they wish to revise the agreement before the end of the period of this agreement. This agreement may be terminated upon a written advance notice of one year from either entity.
