### **This Letter of Agreement is made by:**

On the first party, Faculty of Agricultural Technology Rajamangala University of Technology Thanyaburi (RMUTT), Thailand represented by the Dean of the Faculty of Agricultural Technology Rajamangala University of Technology Thanyaburi.

On the second party, State Polytechnic of Jember Ministry of Research, Technology and Higher Education (POLIJE), East Java-Indonesia represented by the Director of State Polytechnic of Jember Ministry of Research, Technology And Higher Education (POLIJE).

Both parties involved share their academic interests and resources, thereby building a collaboration to promote mutually advantageous cooperation in academic actives aimed at educating qualified human resources.

### **I. Scope of Cooperation**

There are some programs conducted in the cooperation. They are as follow:

#### **1. Student Exchange Program**

1.1 Both parties agree to collaboratively conduct a dual degree program in which this program will begin in ...2016 to 2021...

1.2 The program covers three study programs:

- a. Crop Production Program
- b. Food Science and Technology Program
- c. Animal Science Program

1.3 Students from both parties will take 2 semester of study in which there are 15-22 credit hours in semester.

1.4 After completing the program, student will be awarded the academic degrees of S.ST (Sarjana Sains Terapan) or B.Sc. (Bachelor of Science) from each party. Students will receive academic diplomas and transcripts from State Polytechnic of Jember Ministry of Research, Technology and Higher Education (POLIJE) and Agricultural Technology Faculty of Rajamangala University of Technology Thanyaburi (RMUTT).

## **2. Job Training Program**

2.1 Both parties agree to collaboratively conduct a job training program in which this program will begin in 2016 to 2021.....

2.2 The program covers three study programs and other related study programs. The three study programs are:

- a. Crop Production Program
- b. Food Science and Technology Program
- c. Animal Science Program

2.3 Students from both parties will take 1 semester of job training program there are 8-16 credit hours in one semester.

2.4 After completing the program, students will receive certificates from State Polytechnic of Jember Ministry of Research, Technology and Higher Education (POLIJE) and Agricultural Technology Faculty of Rajamangala University of Technology Thanyaburi (RMUTT).

## **3. Staff Exchange Program**

3.1 Staff development focusing on the training of lecturer and researcher in related fields.

3.2 Collaborative research project requiring the support of project leaders who can work closely with research staffs of State Polytechnic of Jember Ministry of Research, Technology and Higher Education (POLIJE) and Agricultural Technology Faculty of Rajamangala University of Technology Thanyaburi (RMUTT).

3.3 Provision of developmental assistance in learning and teaching programs by visiting academics, as well as research on fields of mutual interest.

## **II. Agreements Related to Specific Activities**

Specific activities, projects, funding and other matter related to the implementation of any of the areas of cooperation in this Letter of Agreement will be negotiated and executed in separate appendices of this Agreement.

### III. Validity

1. The agreement will come into effect once both parties have signed this agreement.
2. The agreement is valid for five years in which both parties have to be committed to the agreed cooperation starting from 2016 to 2021.
3. Subject to approval of both parties, either party may introduce additional topics to the cooperation agreed.
4. The agreement may be extended upon requests from both parties.
5. The agreement may be terminated at any time based upon the mutual decisions of both parties.
6. Amendments to this agreement can be made after both parties agree to do so.


